

## Customer Reviews

This book is required for one of my law school classes. Though it is the most expensive book I have had to date, it was not wildly out of the realm of law school textbooks. Nevertheless, I have only done one class reading so far, and the number of typos/grammar errors is astounding. I have yet to encounter a textbook with so many blatant errors, and it is extremely distracting to the reader. As but two examples:Pg. 55: "Equityholders are frequently said to 'own' the firm or is the 'owner' of the company."Pg. 57: "Thus, enterprises using this form is typically some sort of an investment vehicle..."Professors: Please think twice before requiring a text that is this expensive and this shoddily edited. Surely there are alternatives that facilitate classroom teaching just as well.

This is an excellent book on corporations and noncorporate business entities. The book is well organized, and the commentary is clear and to the point. The book balances the theoretical and practical considerations inherent in a sophisticated corporate law practice.
