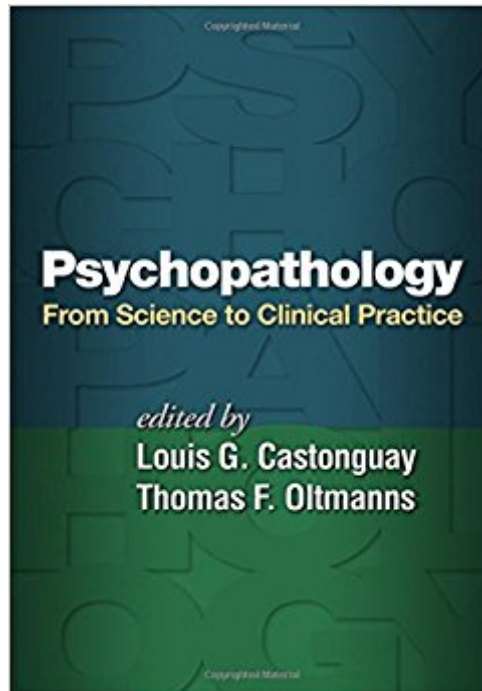

As they wrote that having a phobia is very painful and in some case causes social or occupational impairment, how in the world they could suggest playing such a game? Psychologists and therapists always talk about removing stigma and judgments from mental illness but those authors wrote such a suggestion was very disappointing. Text books don't need to be entertaining or fun to read. If this behavior was not pathologized, in the social measurement they are not kind.
